MO Tariffs & Charges and Imperfections Charge

Introduction

The tariffs and charges published by SEMO in this paper are applicable for the period 01 October 2023 to 30 September 2024 as approved by the Regulatory Authorities (RAs). These tariffs will be applied in accordance with the Trading and Settlement Code – Part B (the T&SC), as may be amended from time to time with the approval of the RAs.

On 30 August 2023 the RAs published an information paper (<u>SEM-23-063</u>) confirming the Market Operator Revenues. On the same date a letter was issued by the RAs to SEMO on the same date confirming the market operator tariffs¹.

On 13 September 2023, the RAs published a decision paper (<u>SEM-23-058</u>) which outlined a number of the SEM tariffs and charges² to apply from 01 October 2023 – 30 September 2024.

On 15 September 2023 the RAs published a decision paper detailing the Imperfections Charge and the Imperfections Charge Factor to be applied from 01 October 2023 (SEM-23-067).

The AOLR charge, applicable to those utilising the AOLR services, is as approved as part of SEMO Price Control Decision <u>SEM-21-073</u>.
