In respect of the Capacity Market Units and Capacity Year listed in this notice, the Participant has acknowledged in their latest Implementation Progress Report that they do not expect to achieve Minimum Completion by the Long Stop Date.

In accordance with J.6.1.3 (f) and J.6.1.5 of the Capacity Market Code, following consultation with the Regulatory Authorities, the System Operators are terminating all Awarded New Capacity in relation to the Capacity Market Units listed above for the 2023/2024 Capacity Year.

In accordance with paragraphs J.6.1.7 and J.6.1.8 of the Capacity Market Code, the System Operators hereby issue this Capacity Termination Notice, which will be forwarded to the Regulatory Authorities and published on the SEMO website.



The System Operators will update the Capacity and Trade Register accordingly by setting the status to “Cancelled” in the Capacity and Trade Register, which has the same meaning as “Terminated” as defined in the Capacity Market Code. A Termination Charge will apply in accordance with J.7 of the Capacity Market Code and an invoice will issue in due course for the amount set out below.
