1. Final Qualification Results

1.1. Purpose of this document

Final Qualification Results provides information relating to items listed within Section E.9.5 of the Capacity Market Code for the T-1 Capacity Auction, for the Capacity Year 2023/2024, which is expected to be held on 18th July 2023. All information set out in this document relates solely to the 2023/2024 T-1 Capacity Auction.




Figure 1 - New and Existing Qualified Capacity by Technology Class
