1. Final Qualification Results

1.1. Purpose of this document

Final Qualification Results provides information relating to items listed within Section E.9.5 of the Capacity Market Code for the T-4 Capacity Auction, for the Capacity Year 2027/2028, which is expected to be held on 26th October 2023. 


Figure 1 - New and Existing Qualified Capacity by Unit Type / Technology Class
