3. Prioritisation Discussions

SEM PC CR292 - MDP Dropdown in the MPI

Will this affect Participant interfaces and how will the dropdown control be populated with the relevant MDP names?

This change will not affect interfaces between Participant Systems and the Central Market Systems. The dropdown control will be populated by MDP Names stored in a table on the Central Market Systems database.

SEM_PC_CR226 – Pop-up reminder of Digital Cert Renewal

Will this change affect Type 3 Participant Interfaces?

No – this change will only be incorporated in the Type 2 interface.

SEM PC CR205 - MPI Weblink User Access

This change was originally proposed some time back by ESB Powergen. At the previous CCF meeting (re October 2013 release) where this change was discussed its priority was downgraded from High to Medium and the Participant specified that they were operating a workaround which reduced the priority of the change.

There was no representation from the Participant at this meeting to support the change and on the basis of previous discussions this Change Request was not proposed for inclusion in the release scope.
