This modification proposes to amend J.6.1.6 of the Capacity Market Code to recognise extensions granted under J.5.7 and J.5.8, which were introduced as a result of SEM-23-101¹ (decision paper) and SEM-23-108² (approved legal drafting).

Legal Drafting Change

J.6.1.6 Except where an extension has been granted under paragraph J.5.5.2, J.5.7 or J.5.8, the System Operators shall terminate all or part of the Awarded New Capacity in respect of New Capacity only for the first Capacity Year for which that capacity was awarded if requested to do so by the Regulatory Authorities if it is determined by the Regulatory Authorities (based on an independently verified report) prior to the T-1 Capacity Auction for the Capacity Year that all or part of the Awarded Capacity is not likely to be delivered by the start of the Capacity Year.

Modification Proposal Justification

This modification is being raised to mitigate any concerns from market participants regarding the termination of Awarded New Capacity that has been granted an extension under the combined and modified delay mods (SEM-23-101).
