1. Final Qualification Results

1.1. Purpose of this document

Final Qualification Results provides information relating to items listed within Section E.9.5 of the Capacity Market Code for the T-1 Capacity Auction, for the Capacity Year 2025/2026, which is expected to be held on 22nd May 2025. All information set out in this document relates solely to the 2025/2026 T-1 Capacity Auction.

1.2. Final Qualification Results

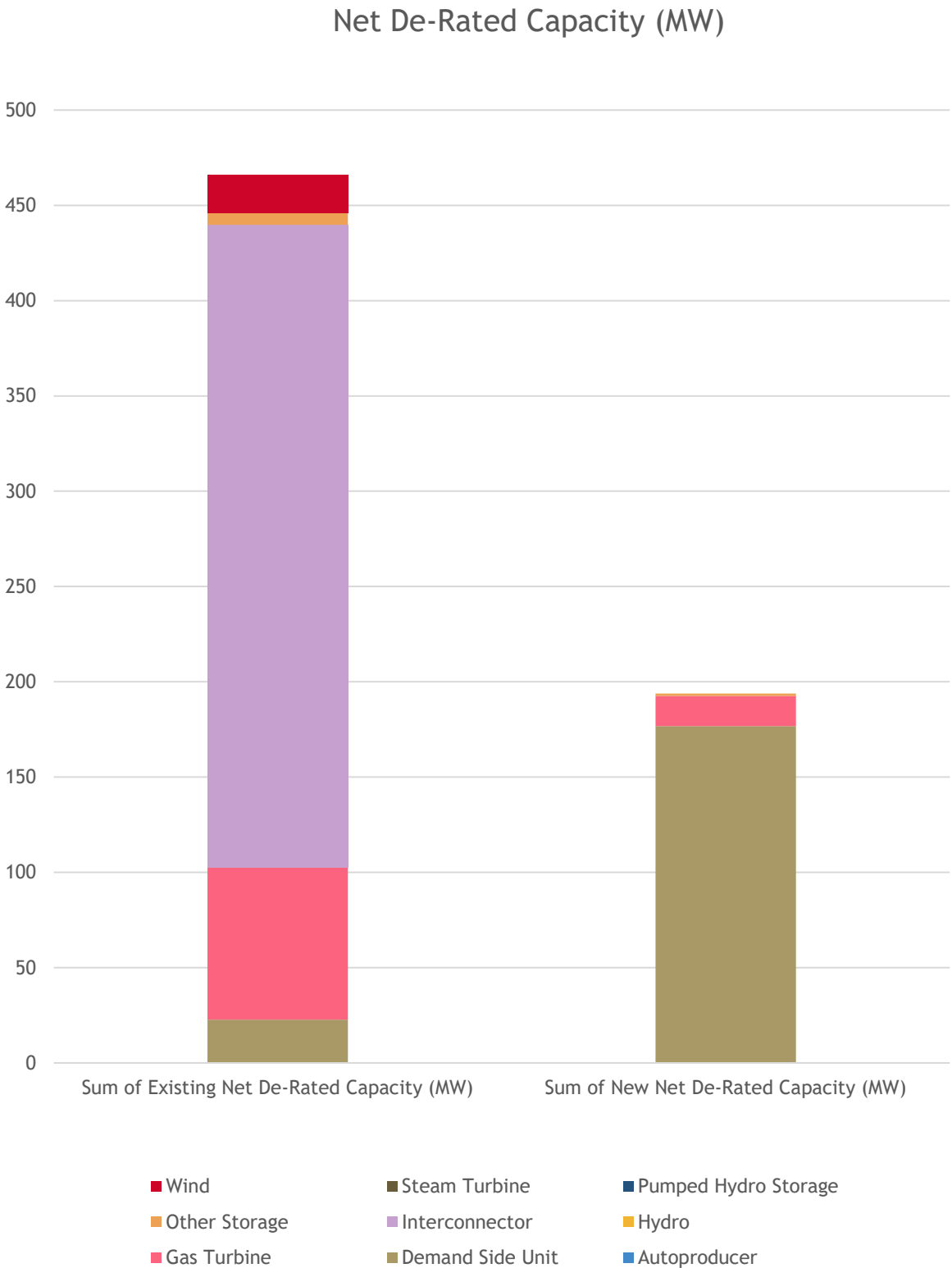


Figure 1 - New and Existing Qualified Capacity by Technology Class
