

#### **Executive Summary**

On 1 October 2018, the revised Single Electricity Market (SEM) went live and is now the enduring operational electricity market in Ireland and Northern Ireland.

This Single Electricity Market Operator's (SEMO) performance report covers the months of July, August and September 2025 of operation and is published in accordance with section B.16.2 of the Trading and Settlement Code and the SEM Committee decision paper issued for the Legacy SEM market.

#### During this period:

- 4 new Parties joined the market; 7 units De-Registered and 9 new Units registered in the market.
- 13 out of 13 Settlement Documents issued on time.
- There were 5 late publications of Indicative, and 7 late publications of Initial Settlement runs as per the Trading and Settlement Code timelines.
- There were 3 payment defaults by 2 Participants as per the Trading and Settlement code timelines.
- There were 0 Credit defaults by 0 Participant as per the Trading and Settlement code timelines.
- There were no Trading & Settlement Code Modifications Committee Meetings during this period. Meeting 130 was cancelled as no New Modification Proposals were received.
- There was one RA Decision received relating to a Modification Proposal.
- 506 general queries were received, and 488 general queries were resolved, with 33 in progress as of 30th of September 2025.




Figure 1 - Indicative Settlement Runs Completed




Figure 2 - Initial Settlement Runs Completed




Figure 3 – Settlement Document Publications Completed

# **4.1 Cash Flow positions for Balancing Market, Capacity Market and Market Operator Charges**

The Balancing Market reflects actions taken by the TSOs to keep the system balanced, for example, for differences between the market schedule and actual system demand. It determines the imbalance settlement price for settlement of these balancing actions. This includes any uninstructed deviations from a participant's notified ex-ante position.

- Positive values indicate Payments were greater than Charges
- Negative values indicate Charges were greater than Payments
- All figures are in Euro

#### 6 Imbalance Price

#### **6.1 Imbalance Price**

There are two types of Imbalance Price referred to in this section; the Imbalance Price which is the price associated with a 5 Minute Imbalance Pricing Period; and secondly, an Imbalance Settlement Price which is calculated as the average of six 5 Minute Imbalance Prices for a corresponding 30-minute Imbalance Settlement Period.

**Figures 4, 5 and 6** show the Imbalance Settlement Prices for July, August & September. All system calculated Imbalance Settlement Prices are published on this graph; both the Market Back Up Price and the 30-minute average of the Imbalance Price.

• The average Imbalance Settlement Price for July was €108.86.




Figure 4 – Imbalance Settlement Price July 2025

• The average Imbalance Settlement Price for August was €107.18.




Figure 5 - Imbalance Settlement Price August 2025

• The average Imbalance Settlement Price for September was €75.55.




Figure 6 - Imbalance Settlement Price September 2025

**Figures 7, 8 and 9** displays the Quantity Weighted Ex-Ante Price as a comparator to the Imbalance Settlement Price. The Quantity Weighted Ex-Ante Price is the value used by SEMO as the Market Back Up Price, should the Market Operator not be able to calculate an Imbalance Settlement Price; based on the average of the six 5 Minute Imbalance Prices for a given Imbalance Settlement Period.




Figure 7 - Imbalance Settlement Price & Quantity Weighted Ex-Ante Price Comparison July 2025




Figure 8 – Imbalance Settlement Price & Quantity Weighted Ex-Ante Price Comparison August 2025




Figure 9 – Imbalance Settlement Price & Quantity Weighted Ex-Ante Price Comparison September 2025




Figure 10 – Highest, Lowest and Average Imbalance Prices July – September 2025

#### 6.2 Exchange Rate




Figure 11 - GBP to EUR Exchange Rate July 2025




Figure 12 – GBP to EUR Exchange Rate August 2025




Figure 13 - GBP to EUR Exchange Rate September 2025

The SEM is a dual currency market, Units based in Northern Ireland submit their Offer Data in GBP. All GBP Offer Data is converted to EUR as part of the Balancing Market price setting process. The GBP to EUR exchange rate is captured below in **Figures 11, 12 and 13.**

#### 6.3 Imbalance Price Generation and Backup Price

The Imbalance Settlement Price is set as the average of the six 5-minute Imbalance Prices. If the Market Operator is unable to calculate any Imbalance Prices within a 30-minute Imbalance Settlement Period within the timeframes set out under the TSC; then the Market Back Up Price will be applied. The Imbalance Settlement Price will use the Market Back Up Price if no 5-minute Imbalance Prices have been published for that period.

- July 2025: 7 Market Back Up Prices applied.
- August 2025: 6 Market Back Up Price applied.
- September 2025: 2 Market Back Up Price applied.

As a result of the approved Mod\_03\_19; the Market Back Up Price is separately applied to a 5-minute Imbalance Price, where that price has not been automatically published. In this instance, the Imbalance Settlement Price will use the average of the automated Imbalance Price or the replacement Market Back Up Price.

#### **Price Definitions**

#### **Missed Prices**

Prices (30 Min / 5 Min) that have failed to calculate, and no price has been generated; either through the standard methodology or via the Back Up Price.

#### **Back Up Prices**

In the context of this report, a Back Up Price refers to a 5-minute price where the Imbalance Price has not been published; the system reverts to the volume weighted average price across all Ex-ante and Intraday timeframes.

#### **Market Back Up Prices**

If the Market Operator is unable to calculate any 5-minute Imbalance Prices within a 30 Imbalance Settlement Period; then the Market Back Up Price will be applied. The Imbalance Settlement Price will use the average of the automated Imbalance Price or the replacement 5-minute Back Up Price.

The Day Ahead Back Up Price is a final fallback price that is to be used in the event of a failure of the automated 30 Minute Market Back Up Price. Typically, this price is only used during planned System Releases/Outages and uses the Day-ahead Auction price only.

#### 8 SEMO KPI Quarterly Update – Storage Technology Facilitation

The KPI as set out in the SEMO Price Control Decision, SEM-21-073, requires SEMO to successfully implement an enduring solution for storage technology facilitation which would enable full participation in the Balancing Market including:

- Registration difficulties resolved.
- Negative PNs can be accepted and processed.

In order to ensure efficiency is maximised across both the Market Operators and System Operators, the battery storage facilitation is incorporated as part of the Scheduling and Dispatch Program (SDP). This work is currently being progressed under initiative #2 Energy Storage Power Station (ESPS) of the SDP. There are six initiatives in scope for SDP and initiative 2 has been identified as the highest priority for delivery following industry feedback and considering TSOs & MO and consumer interests.

#### The latest updates are:

- Phase 3 of Tranche 1 of the program is in progress.
- Phase 3 includes system build, test and implementation, alongside internal readiness activities.
- The user acceptance test and End to End test for the system changes related to ESPS has been completed.
- All non-functional testing has also been successfully executed; Certification Testing, Regression Testing, and Performance Testing now complete.
- The ESPS Cutover Market Participant Guide and Data Conversion Templates were shared with Market Participants on 30/09 and reviewed at a Market Participant Information Session held on 02/10.
- Phase 2 of ESPS Market Participant Interface Testing is in progress and due to complete in mid-October.
- Internal training and cutover preparation is in the final stages ahead of Go-Live on November 11<sup>th</sup>.




Figure 14 - Settlement Information July 2025 (Graph does not include CRM Adhoc)




Figure 15 - Settlement Information August 2025




Figure 16 - Settlement Information September 2025
