This modification will support the objective of delivering New Capacity through the CRM by removing the commissioning milestone from Substantial Financial Completion. It is currently not possible to achieve this milestone at the time when Substantial Financial Completion would be required, as commissioning takes place later in the capacity delivery programme. All other requirements under J.2.1.1 would remain unchanged.
