1 PROGRAMME OF WORK AND SYSTEM UPDATE

The Secretariat welcomed all to Workshop 8 and gave an update on the Programme of Work. It was confirmed that modifications CMC_05_19 and CMC_06_19 were currently out for consultation and a decision is expected on 12th September 2019.

It was noted that there was no system update at this time.

1.1 CMC_07_19

RAs presented Modification Proposal (Presentation Material available here)

It was confirmed by the RAs that this is an Urgent Modification Proposal because it affects both the T-1 & T-2 auctions. There is a plan to have the consultation report out by 9th of September with 3 weeks of consultation to follow. The decision will be published on 14th of October in advance of both auctions. It was also marked as urgent due to both capacity auctions running closely together with the risk that capacity awarded in one auction has impacts on the other auction.

The proposer gave a high level overview of the issues that arise when auctions are run close together. A participant may have qualified for the second auction before the results of the other auction has begun. In this situation a CMU could be awarded for both auctions and the capacity cannot be delivered twice.

The proposer summarised that the modification is relatively complicated and covers the four parts below.

- E.9.6 allows the Final Qualification Results to be amended after they have been published, to take account of the results of the earlier auction.
- F.3 recognises the potential impact of a change in Qualified Capacity on the Demand Curve and allows the RAs to amend the demand curve, if required.
- F.7 manages the situation where Net De-Rated Capacity is modified *after* the Participant has submitted their offer into the second auction.
- F.9.3 considers the situation where the results of the first auction are not available, or change, *after* the second auction has already taken place.

The TSOs' representative made a number of points in relation to the above calling for clarification on the changes to parts of E.9.6. These actions are listed below. In addition, the TSOs suggested that consideration be given to changing the Capacity Auction Timetable instead of introducing complex changes to the CMC and the associated operational processes and systems. There may be systems impacts arising from a change of this nature as currently once the Auction is opened, it is not possible to recalculate qualification results.

A discussion took place regarding F.9.3.3A and options A and B that are available to RAs. A generator member voiced concerns that participants would not know why either option was chosen. The proposer gave reassurance that option B would generally be chosen and the auction would be rerun and that it is a rare event to have auctions so close. It was also stressed that the code may become overly complex and the RAs may wish to give consideration to changes to the Capacity Auction Timetables when developing their decision.

Next steps:

E.9.6.1 - proposer to update text regarding provisional results and be more specific in relation to capacity auction results.

E.9.6.4 - proposer to ensure text states that Qualification Results are republished and not individual Qualification Decisions, which are not published until after the Capacity Auction.

Proposer to consider providing for some of the changes in the Capacity Auction Timetable where applicable as it may be known at the time of publishing the CAT of the need to use the proposed paragraphs.

Proposer to review the demand curve and if anything changes needs to be changed in respect of the LCC Areas.

RAs to publish consultation on proposed mod (along the timelines set out in the RAs' presentation).

Secretariat thanked all for attending the Workshop and confirmed that Capacity Market Workshop 9 will take place on Thursday, 26th September 2019. (Subsequent to this meeting Workshop 9 has been

cancelled as no Modifications Proposals were raised – Workshop 10 is scheduled for Thursday 21st November 2019.)

- 1. TSO to publish Working Group Report.
- 2. RAs to issue Consultation on Urgent Modification Proposal.
- 3. Proposer to provide more clarity around E.9.6 and submit revised version for inclusion in the RAs Consultation.
